

Supplementary Rider Contract for eXTRA cancer waiver

This supplementary rider contract should be read together with the General Provisions for Life Insurance.

1. What do we pay?

- 1.1 eXTRA *cancer waiver* allows you to continue the policy and any attaching riders without paying premiums starting from the next premium due date following the life insured's diagnosis of Major Cancers for the first time during the policy term. The premium will be waived up to the earlier of the policy anniversary before the life insured turns age 86 or the expiry of this rider.
- 1.2 eXTRA *cancer waiver* is a non-participating policy. At expiry date, if we have not paid out any claims, the policy will end and no benefits will be payable. This rider can only be attached at policy application.
- 1.3 The benefits payable under this eXTRA *cancer waiver* and under any guaranteed issuance policies with Critical Illness benefits or Major Cancers benefits issued by Etiqa, shall not exceed a maximum of Three Hundred Thousand Singapore Dollars (SGD \$300,000) for the same life insured.

2. Definition of Major Cancers

A malignant tumour positively diagnosed with histological confirmation and characterized by the uncontrolled growth of malignant cells with invasion and destruction of normal tissue.

The term malignant tumour includes leukemia, lymphoma and sarcoma.

For the above definition, the following are excluded:

- All tumours which are histologically classified as any of the following:
 - Pre-malignant;
 - Non-invasive;
 - Carcinoma-in-situ;
 - Having borderline malignancy;
 - Having any degree of malignant potential;
 - Having suspicious malignancy;
 - Neoplasm of uncertain or unknown behavior; or
 - Cervical Dysplasia CIN-1, CIN-2 and CIN-3;
- Any non-melanoma skin carcinoma unless there is evidence of metastases to lymph nodes or beyond;
- Malignant melanoma that has not caused invasion beyond the epidermis;
- All Prostate cancers histologically described as T1N0M0 (TNM Classification) or below; or Prostate cancers of another equivalent or lesser classification;
- All Thyroid cancers histologically classified as T1N0M0 (TNM Classification) or below;
- All tumours of the Urinary Bladder histologically classified as T1N0M0 (TNM Classification) or below;
- All Gastro-Intestinal Stromal tumours histologically classified as T1N0M0 (TNM Classification) or below and with mitotic count of less than or equal to 5/50 HPFs;
- Chronic Lymphocytic Leukaemia less than RAI Stage 3; and
- All tumours in the presence of Human Immunodeficiency Virus (HIV) infection.

3. Premiums

The premium that you pay for eXTRA *cancer waiver* is level and guaranteed throughout the premium payment term.

4. Termination of benefits

This supplementary rider contract ends when any of the following events happens:

- a. The basic policy ends;
- b. When we admit a claim made under this rider;
- c. When the life insured reaches age 86;
- d. You do not pay the premium in time;
- e. At the expiry date; or
- f. You request us in writing to terminate this rider.

5. What is not covered?

We do not pay the benefit when:

5.1 The Major Cancers is caused by:

- Intentional acts (sane or insane) such as self-harm or attempted suicide within one (1) year of the policy issue date or the last reinstatement date, whichever is later;
- Effects of drug or alcohol addiction; or
- HIV infection, acquired immunodeficiency syndrome (AIDS) and any AIDS related condition, unless the HIV infection is due to blood transfusion or occupationally acquired HIV.
- Any pre-existing condition; or

5.2 The Major Cancers is diagnosed during the waiting period. Waiting period is 12 months from the effective date of this supplementary rider or the last reinstatement date, whichever is later. When this happens, we will return the total premiums paid for this rider without interest, less any expenses incurred by us on your policy; or

5.3 The life insured did not survive for 30 days after the date of diagnosis of the Major Cancers.
