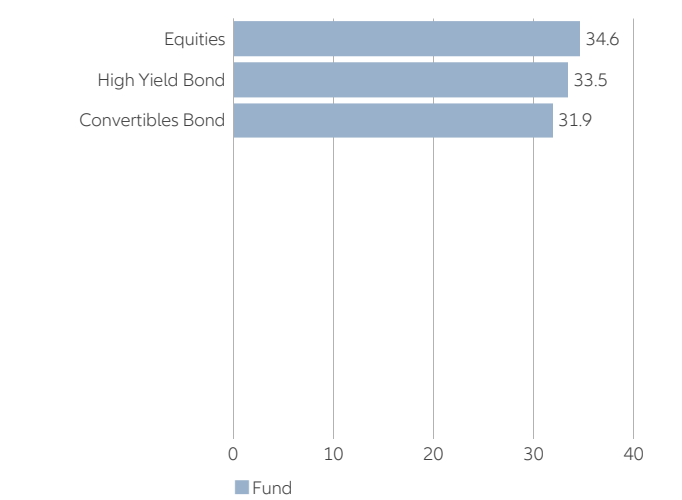

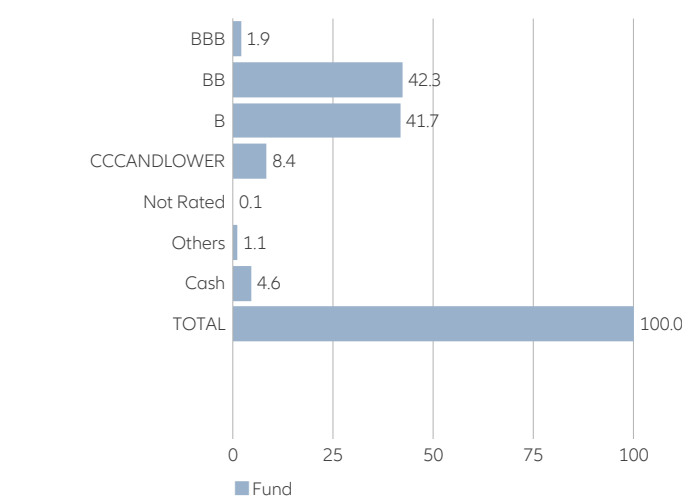
Asset Allocation Breakdown (%)
