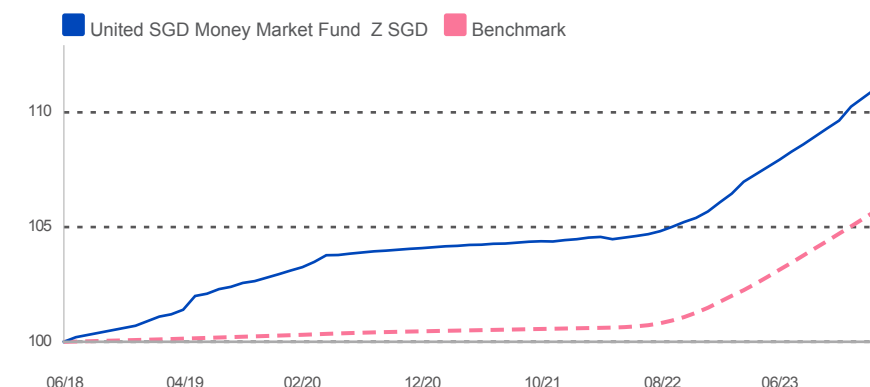


United SGD Money Market Fund

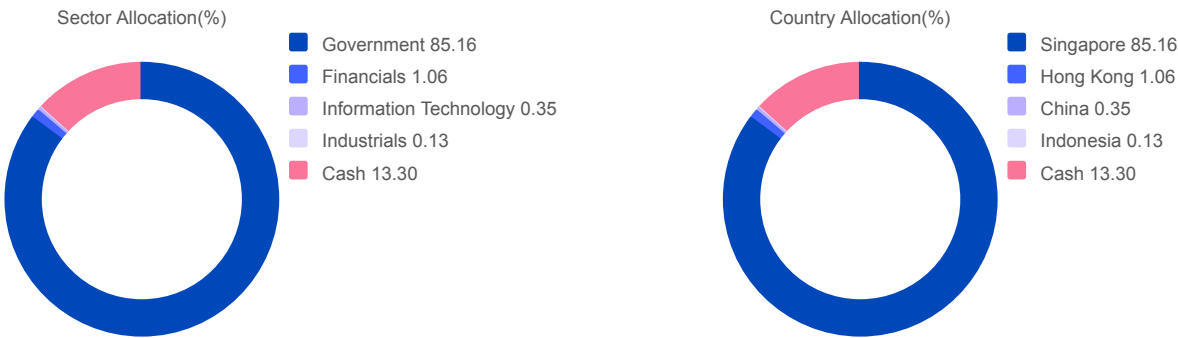
