



## **Limousine Airport Transfer**

## **Terms & Conditions**

## The Privilege

- As Etiqa Insurance Pte. Ltd. ("Etiqa")'s esteemed client ("Esteemed Client"), this privilege is exclusively offered to you, who will be entitled to enjoy up to two (2) complimentary Limousine Airport Transfer within a two (2) year period from the start of your eligibility ("Status Period") ("Privilege").
- 2. "Limousine Airport Transfer" refers to a one-way airport transfer from/to Changi International Airport to/from an agreed destination in Singapore, in a Mercedes E-Class, Alphard/Vellfire (MPV), Mercedes V CLASS (VC). It does not include Seletar Airport and VIP Complex.
- 3. If the above mentioned vehicle type is unavailable, a similar type or category of vehicle will be provided as a replacement.
- 4. Any Limousine Airport Transfer not utilized by the end of the Status Period will lapse and such Privilege will not be permitted to be utilized in any extended duration of the Status Period (if applicable).
- 5. Usage of the Limousine Airport Transfer by you will be considered utilized on the date of the transfer and not the date of booking.
- 6. To redeem the Privilege, you are required to directly contact:

- 7. You shall inform the Partner in advance of your intention to use the Privilege and providing relevant information as required by the Partner in connection with the Privilege.
- 8. All bookings require an advance notice of at least <u>five (5)</u> business days and may be made up to two (2) months in advance.
- 9. Only one (1) vehicle can be used per Limousine Airport Transfer and is subjected to availability.
- 10. You will need to provide pick-up and drop-off details when making a booking, and valid arrival or departure flight details, where applicable. Insufficient or incomplete information or last-minute changes may result in the unavailability of the Limousine Airport Transfer.
- 11. The booking confirmation will be sent via WhatsApp to you, one (1) day prior to the date of transfer by the Partner.
- 12. Travelling companions and the amount of luggage must be kept to the recommended capacity of the vehicle(s).
  - (i) For Mercedes E class, up to two (2) passengers with up to two (2) luggage.
  - (ii) For Alphard/ Vellfire (MPV), up to four (4) passengers with four (4) to five (5) luggage.
  - (iii) For Mercedes V Class (VC), up to six (6) passengers with four (4) to five (5) luggage.

Only hand-carry pieces are allowed in the passenger seats; no luggage pieces are allowed.



- 13. <u>Changi Airport to destination</u> complimentary waiting time will be 60 minutes from the flight's landing time. After 60 minutes of waiting time, it is considered "No Show" by you.
- 14. <u>Pick up to Changi Airport</u> Complimentary waiting time will be 15 minutes from the scheduled pickup time. After 15 minutes of waiting time, it is considered "No Show" by you.
- 15. Cancellations with less than six (6)—hour of notification before the requested pickup time and "No Show" will be considered as utilization of the Limousine Airport Transfer.
- 16. Requests for en-route stop(s) or detours will not be accommodated.
- 17. You acknowledge that the Limousine Airport Transfer will be managed and provided by a third party Partner and you shall not hold Etiqa, its related corporations, employees and/or independent contractors liable for any loss, injury, liability, expense or damage whatsoever or howsoever incurred or sustained by you and/or any other person by reason of, arising from or in connection with the use of the Limousine Airport Transfer provided by the Partner. Neither Etiqa nor the Partner shall be responsible for any late pick-ups or extended travel time due to unforeseen conditions such as bad weather, road and traffic conditions, vehicle breakdown, no show by the driver that may cause you to arrive late and/or miss any flight.
- 18. The Esteemed Client status must be valid at the time of utilizing the Privilege offered by the Partner.
- 19. Etiqa is not the provider of the Limousine Airport Transfer and any related service(s) and makes no representation or warranty whatsoever as to the quality and/or availability of the Limousine Airport Transfer provided and assumes no liability or responsibility for the acts or defaults of the Partner or any other third party service provider or for any non-delivery or non-performance of the Limousine Airport Transfer.
- 20. Etiqa is not an agent of the Partner or any other third party service provider. Any dispute over the service provided should be resolved directly with the Partner.
- 21. Etiqa reserves the right to vary, delete or add to any of these terms and conditions from time to time or to withdraw, suspend or terminate this complimentary Limousine Airport Transfer at any time without prior notice.
- 22. Etiqa's decision on all matters relating to this Complimentary Limousine Airport Transfer shall be final, binding and conclusive on you.
- 23. In the event of any inconsistency between these terms and conditions and any brochure relating to this service, these terms and conditions shall prevail.
- 24. You shall comply with all the terms and conditions as stipulated by the Partner. All Privileges are non-refundable and non-exchangeable for cash or in kind, and is not valid for use in conjunction with other promotions or discounts by Etiqa or the Partner, unless expressly stated otherwise at the time of use.
- 25. Terms and conditions governing the Esteem by Etiqa Programme shall also apply and read together with this terms and conditions of the Complimentary Limousine Airport Transfer.

## **General Terms and Conditions**

- You confirm and agree that consents herein supplement but do not supersede or replace any
  other consents which you may have previously provided to Etiqa, and are additional to any rights
  which Etiqa may have at law to collect, use or disclose your personal data, with or without your
  consent, to the extent permitted under applicable law.
- 3. In addition, where personal data of any person is disclosed by you, you further confirm and represent that you have obtained the consent of the individual concerned for the purposes, unless such consent is not required under applicable laws.
- 4. By participating in this Programme, you agree to our <u>Data protection</u> and <u>Privacy statement</u>.
- 5. In the event of any inconsistency between these terms and conditions and the contents of any marketing and/or promotional materials relating to the Programme, these terms and conditions shall prevail. Any questions or disputes regarding these terms and conditions, shall be resolved at our sole discretion and our decision shall be final and binding.
- 6. If any part(s) of these terms and conditions are found to be void or unenforceable, such provision(s) shall be deemed to be severed and the remaining provisions shall remain in full force and effect.
